1. Booth space is approximately 8 X10 for \$75.00 and 10 X 12 for \$100.00.
2. Any outside vendors, booths # 67 - 69 or vendors with trailers are \$250.00
3. Exhibitor must provide own tables, chairs, backdrops, electrical extensions additional lights, etc.
4. Booths are electrical outlet accessible. Note: Electricity will be provided between the hours of 8:00 a.m. to 10:00 p.m. If overnight power is required, an additional charge of \$50.00 a day will be assessed.
5. L.I.F.E. reserves the right to RESTRICT and REMOVE exhibit that is offensive or interferes with the overall operation of the exhibit barn.
6. Booths will be assigned by the Exhibit Barn Coordinator and by application request (given requested space available). Payment of booths must accompany the application to reserve the space.
7. All booth space will be paid in advance and is NON – REFUNDABLE. There will be NO EXCEPTIONS.
8. Set up Date: Monday, February 26th from 8:00 a.m. to 4:00 p.m. Remove date is Sunday, March 4th by 12:00 noon. Exhibit Barn will close at 12:00 midnight on Saturday, March 3th All Vendors must pick up their items on Sunday, March 4th from 8:00 a.m. – 12:00 noon.
9. Operating hours are 8:00 a.m. to midnight everyday.
10. Booths should be kept neat and in good condition at all times.
11. No cars, trucks, recreation vehicles, or other motorized vehicles will be allowed on the Fair Grounds after set up date. Once your products are unloaded, your vehicle is to be moved to your regular parking area.
12. NO POLITICAL BOOTHS ALLOWED
13. NO LATE SETUPS, NO REFUNDS, IF LATE SETUP IS GRANTED, A FEE OF \$100.00 MUST BE PAID.
14. NO KNIVES, FIREWORKS, POPPERS, FAKE CIGARETTES OR OFFENSIVE MATERIALS TO BE SOLD.
